Update on access to previously visited Health Care Facilities

1 **Purpose of report**

1.1 To update members on progress regarding access issues at a number of healthcare sites previously discussed by London TravelWatch.

2 Introduction

2.1 The table at Annex A sets out healthcares sites in alphabetical order, with an outline of any planned work which will impact on access. Members have previously seen the first three columns: the fourth gives a brief summary of work London TravelWatch has been doing or other progress.

3 Equalities, inclusion and financial implications

3.1 Access to hospitals and major healthcare centres is a key equality issue, recognised by the Government's Social Inclusion Unit report: 'Making the Connections' and the National Institute for Health and Clinical Excellence. Adopting the recommendations made in this report will contribute to promoting equality of access to NHS services.

4 Legal powers

4.1 Section 252A of the Greater London Authority Act places a duty upon London TravelWatch (as the London Transport Users Committee) to keep under review matters affecting the interests of the public, where inadequate public transport access is creating problems for patients, carers and/or staff and to make representations about them to such persons as it thinks appropriate.
