Update on changes to the National Rail Conditions of Carriage (NRCoC) and Regulatory Agreement on Fares and Ticketing (RAFT)

1 Purpose of report

1.1 To update members on progress with changes to the National Rail Conditions of Carriage and the Regulatory Agreement on Fares and Ticketing.

2 Recommendation

2.1 That the report is received for information.

3 Information

- 3.1 Members received a confidential email from the Director, Policy and Investigation on 16 June 2011 outlining changes that were proposed to the above documents and the proposed London TravelWatch response and that of Passenger Focus.
- 3.2 Since that date further discussions have taken place, and it is expected that more formal consultation on proposed changes will take place shortly.
- 3.3 The most controversial proposal in the NRCoC proposals, that of restricting the ability of passengers to use a number of tickets to complete their journey (split ticketing) is not now likely to be taken forward for the present as gaining industry wide agreement proved difficult, however, it is likely that this will re-emerge again at a later date. The introduction of 'concatenation' of fares, which would have reduced the incidence of anomalies in the fare structure that meant that 'split tickets' were cheaper than 'through tickets' is unlikely to be fully achievable within the next five years. Other changes to the NRCoC will go ahead but these are mainly changes that bring the conditions of carriage into line with consumer law, and so would be welcomed by London TravelWatch.
- 3.4 In the case of RAFT, the proposed change which would allow operators to reduce ticket office hours by up to two hours a day without consultation remains. This is of considerable concern, given that the industry is being advised to implement the recommendations of the McNulty review that recommended the closure of ticket offices in station categories D, E and F. Those stations affected by this in the London TravelWatch area are listed in Appendix A. It is noteworthy that a significant number of the stations either do not have a ticket office (and have not done so for many years), or are subject to franchise or concession agreements with Transport for London which contain specific commitments to maintaining ticket office hours. These stations are therefore unlikely to be considered for reductions in these hours. Even if stations do not fall into either of these categories, it should be noted that the hours that the usage of

these – particularly in Greater London is going to be quite high, with the likelihood that at peak times demand for tickets will require the ticket offices to remain open – and it will be in the commercial interests of the franchise operator to maintain that position. If proposals are brought forward to change booking office hours or close them altogether, it is likely that these will need to be considered on a case by case basis by London TravelWatch.

6 Legal powers

6.1 Section 248 of the Greater London Authority Act 1999 places upon London TravelWatch (as the London Transport Users Committee) a duty to consider - and where it appears to the Committee to be desirable, to make recommendations with respect to - any matter affecting the functions of the Greater London Authority or Transport for London which relate to transport (other than of freight). Section 252A of the same Act (as amended by Schedule 6 of the Railways Act 2005) places a similar duty upon the Committee to keep under review matters affecting the interests of the public in relation to railway passenger and station services provided wholly or partly within the London railway area, and to make representations about them to such persons as it thinks appropriate.
